VILLAGE OF SARANAC REGULAR MEETING MINUTES January 8, 2024

The Saranac Village Council Regular Meeting was called to order by President Darby at 7:00 p.m. at the Saranac Village Office, 27 N Bridge Street.

The meeting was opened with the Pledge of Allegiance.

Motion was made by Mulnix, supported by Talcott, to approve the Regular Agenda. All yeas.

Law Enforcement Report

Council members reviewed Ionia County Sheriff Office stats for Village of Saranac patrol for the month of December 2023.

Michael Newton of 46 Dewitt Street, Saranac, was in attendance to inform council that he has applied for a variance from side setback (Zoning Ordinance Section 30.17.08 I. (Accessory Buildings, Structures and Uses). Newton would like to remove his old garage and replace it with a new garage with the south wall constructed and extended at the same current garage setback of 2 feet. A 3-foot variance is requested to maintain the current 2-foot side lot line setback.

Variance requests are heard by the Village Council, acting as the Zoning Board of Appeals, at a Public Hearing.

Due to noticing requirements, the earliest date for a Public Hearing is January 29th. Newton and council members concurred that Monday, January 29th at 6:30 p.m. will work.

Council members reviewed Grand River Excavation's Application for Payment #3, in the amount of \$81,525.81, for the Scheid Park Improvements Project. The application was reviewed for accuracy by Fleis & VandenBrink, prior to being submitted to the Village for payment.

Motion was made by Mulnix, supported by Whorley, to approve Grand River Excavation's Pay Application #3 for the Scheid Park Improvements Project, in the amount of \$81,525.81.

Council members received a Notice of Public Hearing & 30-Day Draft Plan for the Village 5-Year Park & Recreation Plan. The Public Hearing is scheduled to be held on Monday, January 22nd at 7 p.m. at the Saranac Village Office.

Parks & Recreation

In conjunction with the Scheid Park project currently underway, DPW Koster would like to install a section of privacy fencing to "hide" the DPW grounds. Council members agreed that this would be more visibly pleasing, and would enhance the new restroom/concession building.

Mulnix suggested chain-link privacy fencing to remain consistent with current fencing as well as fencing to be installed as part of the current project.
